

**Waiver Release of Liability for Kid Car Parties**

**Severability:** If any provision of this Agreement is held to be invalid, illegal, or unenforceable, the validity, legality, and enforceability of the remaining provisions shall not be affected or impaired thereby.

**Governing Law and Jurisdiction:** This Agreement shall be governed by and construed in accordance with the laws of State of California. Any dispute arising out of or in connection with this Agreement shall be subject to the exclusive jurisdiction of the courts of State of California.
